4. First aid measures

6. Accidental release measures

7. Handling and storage

Precautions for safe handling

Observe label precautions. Keep away from heat, sparks, flame, static discharge and other sources of ignition. VAPORS MAY IGNITE EXPLOSIVELY. Vapors may spread long distances.
