MIXING

Ready to use

APPLICATION

SUBSTRATES

Sanded paint and bare steel and properly prepared surfaces such as aluminum and plastics.

SURFACE PREPARATION

Ensure the surface is free of surface contaminants removing all sanding dust.

APPLICATION

Shake aerosol for 2 minutes. Spray to test application. Apply medium wet coats. Flash 5 minutes between coats. Replace cap to prevent potential misuse.

Tips for Success

- Spray 8 to 10 inches from the surface for best results.
- Spray pressure will be lost during extended application. Shake the can or allow the can to rest for a few minutes to re-establish pressure.
- · Clear the pick-up tube between applications to reduce clogging.
- Invert the can and purge the paint in the pick-up tube with short bursts from the spray head until the spray fan is clear.
